

General description

EPS/PPO granulate which can be moulded into high toughness and/or high temperature foam. The material is available with and without flame retardant. The compressive strength of the material is appr. 15% higher then normal EPS at comparable densities, which makes the material very suitable for impact-absorbing applications.

Processing guidelines

Pre-expansion

Pre-expanding EPS- HT materials can best be done on a pressure pre-expander, because of the higher softening temperatures.

An example of typical settings for EPS-HT 200 are listed below, but will be depending on the used equipment.

Kurtz batch KV 450 pressure pre-expander (batch weight: 2 kg):

Steaming time: 60 sec.

Steam pressure 0,4 bar 40 kg/m3 Steam pressure 0,8 bar 25 kg/m3

Moulding

Maturing time appr. 48 hours.

Moulding of 200 series can be done on a standard moulding machines.

Moulding pressure HT400R 1.3 bar recommended.

Processing conditions for other types can be made available available on request.

Packaging and storage

HT EPS is delivered in 1000KG cardboard octabins.

Other packaging on request.

The material should be used up within 6 months after delivery.

Chemical resistance

HT EPS is resistant to most mineral acids and their water solutions. It is unaffected by alkali solutions regardless of concentration, temperature or duration of exposure.

The material may be detrimentally affected by strong oxidizing acids (i.e.: nitric and perchloric acids). Chlorine, bromine and chlorinated and aromatic hydrocarbons will also dissolve HT EPS foam.

When questions on chemical resistance we recommend that a piece of the foam is evaluated in the anticipated chemical environment.
